In turn, these improved skills lead to a greater and deeper appreciation of the arts, of cultural differences, and of self. Urban Arts' programs are tailored to meet the developmental needs and learning styles of students at grade levels pre-K, K-2, 3-5, and 6-8. A primary program at Urban Arts is Preschool Arts which is an arts based learning program for children ages 3-5. Flexible enrollment plans allow parents to enroll children for half a day up to full-time as needed. Tuition assistance is provided as available.
